### **Motion**

The University of Toledo Medical Center/Medical College of Ohio Hospital (UTMC/MCOH) has been the primary academic medical center where students and residents in the College of Medicine and Life Sciences (COMLS), as well as other students in the healthcare professions, have received their clinical training for over 40 years. In addition, it has been the primary center for clinical research in the COMLS. With the transfer of most residency programs and clinical faculty members to the Toledo Hospital campus and the reported financial instability of UTMC the status of UTMC as a training center for medical professionals and as a research center is in doubt. Therefore, it is so moved that the president of the UT COMLS Faculty Council appoint an ad-hoc committee to review the status of UTMC as it affects the educational and research missions of the COMLS and to make recommendations as appropriate. The committee shall report on its activities at the COMLS Faculty Council meetings and issue a final report in two months from the date of its appointment.

### **COM Executive Council Decision 5/2/2020**

Because of UTMC hospital's financial instability and because its future has not been defined, the COM Faculty Executive Council decided to wait until its status is stabilized. In addition, the UT Board of Trustees is currently involved in negotiating the future of the UTMC hospital.

Overall, we face now two major crisis situations, COVID-19 and 20% cut in UT budget. The COM Executive Council decided to focus on these two important issues.

Drs. Ratnam and Giovannucci have agreed to serve as HSC Representatives if nominated and elected when Senate reconvenes in mid-August.



## a. The Elections Committee shall prepare a slate of candidates for the offices of Vice President and Secretary/Treasurer. b. The office of President

shall be automatically filled by the Vice President and the office of the Immediate Past President will be filled by the President upon the election of the new officers. c. Nominees must be full time faculty members of the COM. They need not be Council Members prior to election. Every effort will be made to identify nominees so that Vice President can rotate in alternate years between clinical and non-clinical/basic science faculty d. The slate of nominees shall be presented to the Council at the March meeting every year, at which time additional nominations may be made by Council Members. All nominees must agree to have their names placed on the bollot. e. All full-time COM faculty members are eligible to vote for COM Council officers. f. A ballot shall be prepared and distributed electronically to all full time faculty members. A line for a write-in candidate will be included. g. Valid ballots will be counted and tabulated by the Elections Committee. h. The candidate receiving the largest number of votes for each office shall be elected and notified by the Secretary prior to the June Council meeting. Announcement of the outcome of the elections will be made by the Chair of the Elections Committee at the June Council meeting. i. In the case of a tie vote, a run-off election may be held if more than two candidates were listed on the ballot. If only two candidates were listed, the tie may be broken by a vote of the Council.
