<b>Method of Reservation</b>	Individual call-in
<b>Billing Instructions</b>	Individuals responsible for own charges
<b>Cut-Off Date</b>	Each sleeping room in your Room Block must be confirmed no later than <b>September 6, 2018</b> . This date will be known as your " <b>Cut-Off Date</b> ." After the Cut-Off Date, you agree that Hotel may offer unused bedrooms held in your Room Block to other customers to reduce Hotel's losses. Confirmation of rooms after the Cut-Off Date will only be accepted based on availability and at the prevailing Hotel rate. To confirm a sleeping room within your Room Block, the sleeping room must be secured with a valid credit card provided by you or the guest attending your Event  If all the sleeping rooms within your Room Block are confirmed using one credit card on or before the Cut-Off Date, you will be required to submit a rooming list containing the name of the guest who will occupy each sleeping room, along with the guest's address.
<b>Taxes</b>	Your group agrees to pay any and all applicable federal, state, municipal or other taxes, or applicable fees. In the State of Ohio, currently the sales tax rate is 17.25%.

**Cancellation Policy**

You may cancel this Agreement only by giving written notice to hotel. No cancellation fees will be owed for cancellation between date of signing and **28 days** in advance of the arrival, however the nonrefundable deposit (if any) will be retained by the Hotel.
