## Collective Bargaining Agreement Quick Reference:

Tenure/Tenure-Track faculty member's workload based on the CBA Article 10.3 provides guidance to teaching, professional activity, and service. CBA Article 10.3 states the "average teaching load, over an academic year, shall be a maximum of 12 credit hours per semester and a minimum of 6 credit hours per semester of instruction." In addition, "The evaluation weights assigned to the three areas in article 9.3.1 shall be linked to the assignment of workload in each of the three areas."

Lecturer Faculty Article 8.4 of the Lecturers CBA provides guidance regarding Lecturers' workload. Section 8.4.1 provides: "The average teaching load of full-time, non-tenure-track faculty as adopted by the Board of Trustees over an academic year shall range between a maximum of thirty (30) credit hours per year and a minimum of twenty-four (24) credit hours per year."

**Teaching Activity Section:** To reflect the course load we ask that you provide the following in the table below:

1. List dual level courses together as a single entry; e.g. ALPHA 4/5000
2. Schedule type: clinical (CL), field experience (FE), lab (LB), lecture (LE), recitation (RE), seminar (SE), studio (ST), etc.
3. Modality: face-to-face (F2F), synchronous remote (remote), asynchronous online (DL), hybrid/blended (blended)
4. Denote overload courses next to credit hours with an asterisk (\*)
5. Enter value for contact hours if they differ from credit hours for labs, clinics, studios, etc. Credit / contact hour equivalents must be based on a set standard and included in the College or Department Workload Guidelines.
