

Parent/Legal Guardian Financial Responsibility Agreement

If a student is under age 18 when signing the University of Toledo's Financial Responsibility Agreement, one of the student's parents or legal guardian must also sign a "Financial Responsibility Agreement" to be eligible to enroll in classes. By signing this agreement, you agree to the following Terms and Conditions:

PAYMENT OF FEES-PROMISE TO PAY

I understand that when my student registers for any class at The University of Toledo or receive any service from The University of Toledo, I accept full responsibility to pay for all tuition, fees and other associated costs assessed because of their registration and/or receipt of services. I further understand and agree that their registration and acceptance of these terms constitutes a promissory note agreement (i.e., a financial obligation in the form of an educational loan as defined by the U.S. Bankruptcy Code at 11 U.S.C. s. §523(a)(8)) in which The University of Toledo is providing educational services, deferring some or all of my payment obligation for those services, and I promise to pay all assessed tuition, fees and other costs by the published or assigned due date.

I understand that if my student drops or withdraws from some or all of their classes for which they registered, I will be responsible for paying all or a portion of tuition and fees in accordance with the published tuition refund schedule located on the Treasurer's Office website: <https://www.utoledo.edu/offices/treasurer/>. I have read and understand the terms and conditions of the published tuition refund schedule and understand those terms are incorporated herein by reference. I further understand that my student's failure to attend class or receive a bill does not absolve me of my financial responsibility as described above.

DELINQUENT ACCOUNT/COLLECTION

Financial Hold: I understand and agree that if I fail to pay my student account bill or any monies due and owed. The University of Toledo by the scheduled due date, The University of Toledo will place a financial hold on my student account, preventing me from registering for future classes, requesting transcripts, or receiving my diploma.

Late Payment Charge: I understand and agree that if I fail to pay my student account bill or any monies due and owed. The University of Toledo by the scheduled due date, The University of Toledo will assess a late payment per month on the past due portion of my student account until my past due account is paid in full.

Accelerate Indebtedness. To declare the principal balance plus late fees immediately due and payable in full.

Deny Residence Hall Access and Deactivate Rocket Card Privileges. Resident may not be permitted access to The University of Toledo housing or meal plan funds and other associated Rocket Card privileges if Resident's balance is not paid in full or until an approved payment plan is in place. Should Resident default in complying with any payment dates for any of Resident's financial obligations, The University of Toledo may seek any remedy in law or in equity, including specific performance of the Resident's obligations or seek money damages. Resident agrees to pay all reasonable costs and expenses that are incurred by the University in enforcing this provision.

Collection Costs. I understand and accept that The University of Toledo may hire or pay someone to help collect this Agreement if I do not pay. I will pay The University of Toledo that amount. This includes, subject to any limits under applicable law, collection costs, interest, expenses for bankruptcy proceedings, and appeals. If not prohibited by applicable law, I will also pay any court costs, in addition to all other sums provided by law. If there is a lawsuit, I agree upon University's request to submit to the jurisdiction of the courts of the State of Ohio, without regard to conflict of laws. Finally, I understand that my delinquent account may be reported to one or more of the national credit bureaus.

Invalidate Student's Registration. Failure to meet my financial obligations with the University may result in an administrative drop of my student's current classes.

Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of Ohio. Any action or proceeding to enforce or arising out of this Agreement may be commenced in the courts of the State of Ohio or the United States District Court in Columbus, Ohio. The party's consent to such jurisdiction, agree that venue will be proper in such courts and waive any objections based upon forum non-conveniens.

I FURTHER ACKNOWLEDGE

Method of Communication: I understand and agree that The University of Toledo uses e-mail as an official method of communication with my student, and that therefore my student is responsible for reading the e-mails they receive from The University of Toledo on a timely basis.

Contact: I authorize The University of Toledo and its agents and contractors to contact me at my current and any future cellular phone number(s), email address(s) or wireless device(s) regarding my student's delinquent student account(s)/loan(s), any other debt I owe to The University of Toledo, or to receive general information from The University of Toledo. I authorize The University of Toledo and its agents and contractors to use automated telephone dialing equipment, artificial or pre-recorded voice or text messages, and personal calls and emails, in their efforts to contact me. Furthermore, I understand that I may withdraw my consent to call my cellular telephone using automated telephone dialing equipment by submitting my request in writing to The University of Toledo Treasurer's Office, 2801 W. Bancroft, MS 331, Toledo, Ohio 43606 or in writing to the applicable contractor or agent contacting me on behalf of The University of Toledo.

Updating Contact Information: I understand and agree that I am responsible for keeping The University of Toledo records up to date with my current physical addresses, email addresses, and phone numbers. Upon my student leaving The University of Toledo for any reason, it is my responsibility to provide The University of Toledo with updated contact information for purposes of continued communication regarding any amounts that remain due and owing to The University of Toledo.

Entire Agreement: This agreement supersedes all prior understandings, representations, negotiations and correspondence between the student and The University of Toledo, constitutes the entire agreement between the parties with respect to the matters described, and shall not be modified or affected by any course of dealing or course of performance. This agreement may be modified by The University of Toledo if the modification is signed by me. Any modification is specifically limited to those policies and/or terms addressed in the modification.

Financial Aid: I understand that aid described as "estimated or Memo" on my student's Financial Aid Award does not represent actual or guaranteed payment but is an estimate of the aid they may receive if they meet all requirements stipulated by that aid program.

I understand that my student's Financial Aid Award is contingent upon his/her continued enrollment and attendance in each class upon which their financial aid eligibility was calculated. If he/she drops any class before completion, I understand that their financial aid eligibility may decrease and some or all the financial aid awarded to him/her may be revoked. If some or all their financial aid is revoked because he/she dropped or failed to attend class, I agree to repay all revoked aid that was disbursed to my account and resulted in a credit balance that was refunded to him/her.

Method of Billing: I understand that The University of Toledo uses electronic billing (e-bill) as its official billing method, and therefore my student is responsible for viewing and paying their student account by the scheduled due date. I further understand that failure to review his/her e-bill does not constitute a valid reason for not paying their bill on time. E-bill information is available at [MYUT](#).

Billing Errors: I understand that administrative, clerical, or technical billing errors do not absolve me of my financial responsibility to pay the correct amount of tuition, fees and other associated financial obligations assessed because of my student's registration at The University of Toledo.

Returned Payments/Failed Payment Agreements: If a payment made to my student's account is returned by the bank for any reason, I agree to repay the original amount of the payment plus a returned payment fee of \$30.00. I understand that multiple returned payments and/or failure to comply with the terms of any payment plan or agreement I sign with The University of Toledo may result in cancellation of my student's classes and/or suspension of my eligibility to register for future classes at The University of Toledo.

1098T Tax Forms: My student agrees and consents to receive their 1098T tax form electronically. They understand that their consent for an online electronic 1098T form means that a paper copy of the 1098T form will not be mailed. A printed form may be obtained by logging into their MYUT portal.
