Faculty Senate Report
Board of Trustees Meeting
September 25, 2024

Faculty Senate has had two meetings since the start of the 2024-25 school year. At our August 27 meeting, Interim President Matt Schroeder presented his vision for the University of Toledo and answered questions submitted by faculty and staff. Although the conversation was wide-ranging, here are the major takeaways:

1. Faculty are generally receptive to the Interim President's vision of the University as a regional powerhouse with new student recruitment focused on the radius where we have traditionally recruited well.
2. Faculty are generally receptive to administrative cost reductions if they do not degrade the services we provide to faculty, staff, new and continuing students, or impede our ability to enroll new students and retain current students.
3. Faculty strongly believe declining enrollment is a crisis for the University. It is not enough to "right-size" the University. Other, similar, universities are growing enrollment while our enrollment is declining. Leadership in our enrollment enterprise is lacking and it is not clear that we are implementing the strategies offered by consultants, such as the Art and Science Group. Faculty are interested in helping to recruit students to the University but need help organizing those efforts.
4. Faculty question the wisdom of searching for a permanent provost while we have an interim president. This may lead to further administrative turnover in the near future if the next permanent president does not prefer the provost hired this year. Also, because the provost office is expanding to include more areas in Academic Affairs and changing to a new advising system, it is not yet clear what areas of expertise are needed in our next provost.

At our September 10 meeting, Interim Provost Scott Molitor presented the new, much expanded, provost office organization chart (in draft form) and discussed the planned change from decentralized/distributed advising to centralized advising. Most of the meeting was focused on discussing the data driving the centralized advising push. Here are the major takeaways:

1. Faculty are concerned that the provost office is being given too much responsibility without having an appropriate increase in resources and staffing to successfully serve students, faculty and staff in the division of Academic Affairs.
2. Faculty are skeptical of the data being used to justify the change to centralized advising. While it is clear that we need to continue to improve our retention and graduation rates, we were not presented with any data that convincingly showed centralized advising will achieve these goals.
3. There has been no discussion of how to achieve improved student retention and graduation rates by means other than centralized advising.

4. It is not clear that students have been involved in the discussion about centralized advising.
5. Although Interim Provost Molitor assured Faculty Senate that centralized advising will not be used to cut the number professional advising staff at the University, this continues to be a concern raised by faculty and staff.

We appreciate the willingness of Interim President Schroeder and Interim Provost Molitor to engage Faculty Senate in their planning for the future of the University. On October 2, Interim Provost Molitor will present his plan for academic program prioritization to Faculty Senate. We are hopeful that this year's prioritization process does not distract us from the important work of recruiting new students and retaining and graduating continuing students.

Graduate Council Report to Board of Trustees Academic and Student Affairs Committee, September 25th, 2024 prepared by Dr. Barbara Saltzman, University of Toledo Graduate Council Chair

This report includes the activities of Graduate Council (GC) since our last report on June 25th, 2024. Since June the council has had two bimonthly meetings to conduct regular business, hear presentations from guest speakers and address new business brought forth by members. Over Summer I and Summer II terms, GC has approved numerous applications for new and renewed graduate faculty status which provides ability of individuals to teach graduate courses and also serve in various capacities on graduate advisory committees to mentor graduate students on completion of their degrees. Our curriculum committee is almost fully populated and will begin to review and approve proposals for new or modified graduate programs and courses as faculty work to update offerings and pursue advances in teaching and introduce new innovative degree programs. I will have updates on this committee's work for the December board meeting.

On September 17th, Dr. Scott Molitor, Interim Provost and Executive Vice President for Academic Affairs joined our meeting to discuss topics relevant to graduate programs, including program prioritization activities and the graduate recruitment committee. We have Interim President Matt Schroeder scheduled to address the Council at the October 29th meeting. Additionally, we have invited Alana Malik to speak on assessment at the University and intend to include additional speakers throughout the fall to share information on AI and library resources for reduced publication costs.

We continue to review policies and make recommendations as they pertain to this body, and will be gathering input for the fall graduation speaker selection. We also receive regular updates from Dr. Dan Hammel, Acting Vice Provost for Graduate Affairs, Research Council via Dr. Connie Schall, and the Graduate Student Association by GSA vice-president Saad Andalib.

- Dining

This new school will be a hub for data science programs and activity at The University of Toledo. It will be the home of the current B.S. in Data Science and the home for the future online M.S. in Data Science that is currently under development.

Rationale: The new school will be a mechanism for bringing together an interdisciplinary group of faculty from several departments and colleges who all have an interest in data science. The focus will be on educating students so they can learn the entire spectrum of data science methods from data collection through interrogation and analysis, visualization, and communication.

WHEREAS, on June 20, 2016, The University of Toledo Board of Trustees (UToledo Board) approved Resolution No. 16-06-13, an initial affordability and efficiency review and implementation plan based on the Task Force's recommendations; and

WHEREAS, on December 6, 2023, the UToledo Board approved Resolution No. 23-12-40 to approve the University's FY23 Affordability and Efficiency report; and

WHEREAS The University of Toledo's administration updated the Affordability and Efficiency report to include quantifiable measures of actions taken in FY24 and to address the new points of emphasis that reflect additional priorities of the DeWine-Husted administration; and

WHEREAS the Ohio Department of Higher Education requires submission of the Affordability and Efficiency report to the Chancellor.

**RATIFICATION OF THE COLLECTIVE BARGAINING AGREEMENT
BETWEEN THE UNIVERSITY OF TOLEDO AND THE
UNIVERSITY OF TOLEDO POLICE PATROLMAN'S ASSOCIATION**

- WHEREAS, the Collective Bargaining Agreement between The University of Toledo and the University of Toledo Police Patrolman's Association ("UTPPA"), is effective from January 1, 2022, through December 31, 2024; and
- WHEREAS, The University of Toledo and UTPPA have been engaged in collective bargaining under the provisions of Ohio Revised Code 4117, the State of Ohio's collective bargaining law, which has been assigned State Employment Relations Board (SERB) Case No. 2024-MED-09-1036; and
- WHEREAS, the parties negotiated a tentative agreement for a term to run from January 1, 2025, through December 31, 2027, which was ratified by UTPPA on October 18, 2024; and
- WHEREAS, the tentative agreement provides for a market adjustment and a 2% general increase effective January 1, 2025, a 2% increase effective January 1, 2026; and a 2% increase effective January 1, 2027.

NOW, THEREFORE, BE IT RESOLVED,

that the Board of Trustees of The University of Toledo hereby ratifies the agreement between The University of Toledo and UTPPA for a collective bargaining agreement to run from January 1, 2025, through December 31, 2027.
