(A) Policy statement

This policy describes the general process for current medical students who wish to take graduate courses at the University of Toledo.

(B) Purpose of policy

To describe general criteria for medical students who would like to take graduate courses at the University of Toledo.

(C) Scope

This policy is for current medical students at the University of Toledo.

(D) Procedure

Medical students who wish to take graduate courses at the University of Toledo must meet the following criteria:

- (1) Students shall be duly registered in the College of Medicine & Life Sciences.
- (2) Students shall receive approval from the Associate Dean for Student Affairs (or designee) and the College of Graduate Studies designee.
- (3) Students shall receive approval from the applicable course director or instructor.

If part-time medical students have permission to register for graduate courses, the tuition and fees will be charged according to the College of Medicine & Life Sciences tuition and fee schedule. Full-time medical students who are approved to take graduate courses will not be required to pay instructional or ancillary fees for these courses.
