(A) Policy Statement

During the absence of the University of Toledo Medical Center (UTMC) Chief Executive Officer, the Chief Operating Officer will be designated as the person in authority of the University of Toledo Medical Center and its Ambulatory Services. If the Chief Executive Officer and the Chief Operating Officer are both absent, the Chief Medical Officer will be designated as the person in authority at UTMC.

(B) Purpose of Policy

To ensure continued maintenance of the chain of command and to facilitate problem resolution during the absence of the Chief Executive Officer.

(C) Procedure

The hospital operator maintains a copy of the on-call list.

- 1. If the Chief Executive Officer is unavailable, the Chief Operating Officer should be contacted.
- 2. If the Chief Executive Officer and Chief Operating Officer are both absent, the Chief Medical Officer should be contacted.
- 3. During the evening, weekends or holidays, the Chief Executive Officer or the Administrator on Call should be contacted by calling the hospital operator. The scope of authority for the Administrator as follows:
 - a. Interpretation of Hospital Policies and Procedures.
 - b. Decision making in situations which are not addressed by established policy and procedure.
 - c. Works with Administrative Staff, Medical Staff, and Employees to resolve or avert problems.
 - d. Approval of expenditures within the guidelines of established financial policy.
