## CONTROLLED SUBSTANCES DISCREPANCY FORM

## CHECKLIST OF STEPS TO BE TAKEN IN CASES OF SUSPECTED LOSS OR THEFT OF CONTROLLED SUBSTANCES

- 1. If a registrant has a reasonable belief or suspicion that there has been (a) theft of any amount of a controlled substance; or (b) significant loss of a Controlled Substance, the event must be promptly reported to the following units:
  - University of Toledo IACUC Office
  - University of Toledo Police Department (UTPD)
  - U.S. Drug Enforcement Agency (DEA)
  - Ohio Board of Pharmacy (OBP).

If there is doubt about whether a report should be made, err on the side of reporting.

- 2. To determine if a loss is "significant," the registrant should consider the following factors:
  - a. The actual quantity of controlled substance lost in relation to the type of activities performed by registrant.
  - b. The specific controlled substance that was lost and whether it is a likely candidate for diversion.
  - c. Whether the loss can be associated with access to the controlled substances by specific individuals.
  - d. Whether the loss can be attributed to unique activities that take place involving the controlled substances.
  - e. Whether there has been a pattern of losses of a specific period or alternatively, whether the loss appears to be random.
  - f. The results of any efforts to resolve the loss.
  - g. Any local trends or other indicators that the lost controlled substance has been diverted.

Registrants with questions about how to apply the foregoing factors in determining if a loss is significant can contact IACUC for advice.
