Important Notes

In those instances where assessments are not passed, no transcription of the PLA attempt will be added to the student record.

A student must be admitted to The University of Toledo to be eligible to pursue prior learning assessment credit by exam or portfolio and must be currently enrolled for credit to be posted. If the student is not enrolled in the term in which the assessment is completed, the credit hours will not be posted until the next semester of enrollment.

There is no limit on the number of hours of credit by prior learning assessment which a student may pursue; however, <u>only</u> a maximum of 30 hours may count toward graduation in any program.

A student must earn a grade of "C" or better to earn credit by PLA. Credit by Exam and/or Portfolio are recorded with letter grades, which contribute to student grade point averages (GPA's).

The faculty assessment stipend is \$75 per course for every student assessment completed, regardless of student outcome, payable in the following semester by University College.

Student assessment fees are processed and billed by the University Credit Assessment Center and are independent of faculty stipends.
